**PROBABLE CAUSE AFFIDAVIT**

Affiant swears or affirms that he/she believes and has good cause to believe that:

Detective Sean Liesenfelt, Indiana University Northwest Police Department, was assigned the duty of investigating a reported sexual battery which occurred in Lake County, Indiana. During the course of my investigation, I reviewed statements and reports of ██████████, a person I believe to be truthful and credible because she spoke of facts within her personal knowledge.

██████████ related the following: She is 17 years old. On March 5, 2017 at approximately 1:47 pm at the location of 65 W. 33rd Avenue in Gary, she was at Savannah Hall Gym on the Indiana University Northwest campus doing her job as a referee for a private volleyball club. When a particular volleyball match was over, she was going to head upstairs to retrieve a volleyballs that inadvertently got knocked into the upper balcony of the gym. Before going upstairs, she spoke to a known male subject named Jan Emilio Torres who was facilitating the volleyball event. During their conversation, Torres told her that when they go get the ball, they were "going to fight". She went along with this comment believing the "fighting" to be in a playful nature. She and Torres then entered the stairwell to retrieve the volleyball. She and Torres then began "play fighting" which she went along with. Torres then grabbed her and placed her in a "choke hold" (not tight enough to injure her but tight enough to show his dominance). He then pushed her up against the wall and made her tap out which she did. While still behind her, he asked "Who wins?" and she replied "You do". He then smacked her buttocks. He then turned her around, pushed himself against her, and kissed her. When she pushed him away and went to walk away, he grabbed her and kissed her again. She then pushed him away again and went through the door back into the gym area. He then followed her into the gym area and stated "it was good" and that "her lips were sweet". During this incident, she did not consent to the above described acts that went beyond the "play fight". Prior to this incident, she and Torres have known each other for several years and they would "play fight" from time to time.

Affiant's investigation reveals that Jan Emilio Torres was born in 1968 and he is 48 years of age.
