<p>SUMMARY: Andrew Freund and JoAnn Cunningham report their child, Andrew "AJ" Freund has gone missing. The child was last seen 04/17/2019 at approximately 2130 hours. The case is currently under investigation.</p>			
<p>NARRATIVE: On 04/18/2019, X321 was dispatched to 94 Dole Ave reference a missing juvenile. Upon my arrival myself and Ofc. Burr and Ofc. Jedlicka met with Andrew Freund in the driveway. Andrew said he wanted to report his child, Andrew "AJ" Freund, as missing. Andrew stated woke up at 0500 hours to get ready for a doctor's appointment. Andrew stated as he was getting ready, he noticed nothing out of the ordinary. Andrew left for his doctor's appointment and didn't return home until approximately 0800 hours. I asked Andrew what AJ was last scene wearing. Andrew described AJ was wearing a "blue Mario sweatshirt and black sweatpants." I asked Andrew when he last saw AJ and he said it was when he was put to bed at approximately 2130 hours Wednesday night (04/17/2019). Andrew appeared very calm throughout my interaction with him, not showing much emotion when speaking about his missing child. I asked Andrew if he had a recent picture of AJ. Andrew searched his photos in his phone, but wasn't able to find a picture. Also on scene was AJ's mother, JoAnn Cunningham, and [REDACTED]. Andrew referred me to JoAnn, so I went to speak with her inside the residence. Upon entering the kitchen of the residence, I noticed the house was in disarray. There was nearly no counterspace in the kitchen and half of the kitchen floor was missing, exposing the bare wood floor board. I met with JoAnn who seemed frantic, crying and having scattered thoughts. I asked JoAnn if she had a recently taken photograph of AJ so I can disseminate it to other units and Crystal Lake employees who were in the area. JoAnn was able to provide me a picture, which I was able to share. As I was sharing the picture, JoAnn received a phone call from her boyfriend, [REDACTED] who was incarcerated at the time. JoAnn had her phone on speaker and I heard [REDACTED] ask her if she found AJ yet though she never said he was lost while I was present at their residence.</p> <p>Both parents described AJ as being approximately 3'5", 60-70 lbs, having a thin build and dirty blonde buzzed hair. Both Andrew and JoAnn said AJ does not have any special needs and is not prescribed medication. I continued and asked Andrew what AJ's eye color was and he told me he thought they were blue. When I asked JoAnn she said his eyes were brown. Once Andrew heard JoAnn's answer he changed his statement and agreed AJ's eyes are brown. As I was speaking with the parents Ofc. Pluviose, Ofc. Stopka, Commander Neumann, Commander Miller, Det. Eitel, and Det. Duncan arrived on scene searching for the child.</p> <p>I notified SEECOM and provided an updated description of AJ, which SEECOM used to send out a McHenry County broadcast for personnel to be on the lookout for AJ. As I continued to speak with JoAnn and Andrew Ofc. Burr, Ofc. Jedlicka, Ofc. Stopka, Det. Duncan, and Det. Eitel searched the residence with JoAnne's consent. Andrew advised they had searched the house for over an hour before notifying the CLPD. I assisted and searched the residence for AJ, which I found the house was very messy and cluttered, leaving very little floor space to walk on in certain areas. I searched the basement of the residence and noticed there were garbage bags full of miscellaneous materials thrown on top of one another, leaving a narrow open path I could walk through. I moved various garbage bags in search for AJ, but only noticed cockroaches scattering away. After I searched the basement, I went upstairs to AJ's room. Before I entered AJ's room, I observed a sliding chain lock on the outside of the room. Upon entering his room, I observed an unkept converted crib/toddler bed which Andrew said AJ sleeps in. I noticed mouse droppings along the bed sheets. The mouse droppings were also observed along the floor of AJ's bedroom and throughout the house. AJ also had two windows in his bedroom, one facing south and the other facing west. Ofc. Burr asked if AJ had ever tried to exit the window facing south since it was directly above the garage. Andrew said AJ had exited the window once before, so he secured it by drilling two screws into the window. Ofc. Burr attempted to open the window, which he stated opened with minimal effort. We also asked why there was a lock on the outside of AJ's bedroom door. Andrew stated they lock his door during the over night hours.
