Pursuant to the Illinois Funeral Directors and Embalmer's Licensing Code, 225 ILCS (2010), Section 41/15-45(b), a Rule does hereby issue to Antwon A.K.A. Anton/Antonio Godfrey D.B.A. Living Waters Funeral Service to show cause why the Division of Professional Regulation of the Department of Financial and Professional Regulation ("Department") should not issue an Order to Cease and Desist the unlicensed practice of Funeral Directing and Embalming, by offering services which constitute the unlicensed practice thereof, in violation of 225 ILCS (2010), Section 41/10-5.
