We are excited to announce that starting from January 1, 2023 you will now be able to make payments using our Liberty X and Coinstar Bitcoin machines. This additional payment method gives you the convenience and security of using Bitcoin for your transactions for all government officials. These kiosk units only dispense your voucher and our kiosk in the department receives them. This is the only way to securely uplift all court fees, fines, and citations for the government to record and hold all records of transactions. The purpose of this system is because sensitive information is not to be taken over the phone due to a high influx of scams because it is important to protect individuals' personal and financial details from falling into the wrong hands. Scammers often use technology and deceptive tactics to trick people into divulging sensitive information such as social security numbers, bank account details, or passwords. These scams can result in various forms of fraudulent activities, including identity theft, financial loss, and unauthorized access to personal accounts. To ensure safety and security, organizations and individuals have adopted a policy of not taking sensitive information over the phone. Instead, they typically request people to provide such details through more secure channels, such as in-person transactions, encrypted online portals, or via secure email platforms. This precautionary measure helps minimize the risk of falling victim to scams and protects individuals' sensitive data.

To utilize this service, please follow the steps below:

1. Locate the nearest Liberty X or Coinstar Bitcoin machine. You can find the nearest machine by visiting our website or by using the dedicated mobile application.
2. Once you have identified the machine, ensure that you have an official government agent assisting you through this process.
3. Go to the designated Liberty X or Coinstar machine assigned to you by your agent. Upon arrival and operation of this kiosk select the option for payment using Bitcoin/Cryptocurrency.
4. You will be prompted to scan a QR code provided by the Agent or enter a unique payment code. This information can usually be found on the payment invoice or communicated to you by the agent.
5. After scanning the QR code or entering the payment code, the machine will display the payment details, including the amount to upliftment of your citation/bond fees.
6. Once you have verified the payment details, select the "Send" or "Confirm" option on the machine's interface.
7. Upon successful completion, a confirmation message will be displayed on the machine, indicating that your payment has been processed. Please do not damage this voucher as it will be needed to be placed inside our departments kiosk.
8. **DO NOT GIVE ANYONE YOUR VERIFICATION CODE.** This code is uniquely designed for you and you alone. Only our corresponding kiosk will accept the verification code upon entering this information in our kiosk.

Please note the following important points:

- Some Liberty X and Coinstar Bitcoin machines may have a limit on the maximum transaction amount. This information will be clearly displayed on the machine. Make this information known to your agent in reference to the amount you will be uplifting.
- In case of any issues or concerns during the payment process, please contact our customer support team, who will be available to assist you. Sometimes your bank may need to be notified.
- At this kiosk we don't accept credit cards.
- Your designated amount must be in the form of debit or cash to obtain your voucher. It must also only be on either your checking or savings in one whole amount.
- If you have a limit with your bank you should notify them to allow that transaction to be made so a hold can be avoided. Let your agent know to allow that third party call to be made.
- If you are in possession of cash a unique 10 digit docket number will be assigned to you.

This system allows you to engage in civic participation by conveniently submitting fees, fines, and court-ordered vouchers directly to our department for the review of relevant government officials and state finances.
