
This affiant Investigator R.O.Campen has been in law enforcement since 1984. I'm currently assigned to the Wake County Sheriff's Office Person Crimes Unit. This unit investigates, Homicides, Rapes, Armed Robberies, and Missing Persons, all dealing with crimes against the person. I have worked in Criminal Investigations as an Investigator in the "Person Crimes Unit" for 6 years four months. R.O.Campen has received in excess of 1000 Hours of Law Enforcement Training through an assortment of training programs including: North Carolina Justice Academy, Wake Technical Community College, Coastal Plains Police Academy. I have investigated all types of crimes including Death Cases, Sexual Assaults, Robberies, Physical and Child Sexual Abuse, Drug Violation, Arson, and Internet Computer crimes, Burglaries, Breaking and Entering, Larcenies, and Fraud. I make this affidavit based on my training and experience together with statements made from the victim and witnesses that I believe to be credible.


The Wake County Sheriff's Office received a dispatch call around 0123Hrs on 04/09/09 in reference to a female person with a gunshot wound to the shoulder. Wake County Sheriff's Deputies responded to the scene at 6143 Vicky Dr. Raleigh NC 27603. Where they found an elderly female who had been shot in the shoulder with a shotgun. The victim and the suspect who was still on scenc were located by responding deputies and the female was transported to Wake Medical Center for treatment. The suspect is her grandson and he was moving out of the home when he had a confrontation with the victim while she was in her bed. He had gone into the victim's bedroom and was attempting to get her safe from under her bed when she was startled by the noise being made beside the bed. That when she sat up in the bed she saw the suspect on the floor and that he was holding a


