HOLLYWOOD GETAWAY FOR TWO LOCAL SWEEPSTAKES (the "Sweepstakes")

OFFICIAL RULES**

**I. NAME OF SPONSOR**

American Broadcasting Companies, Inc. (hereinafter referred to as "Sponsor") 77 West 66<sup>th</sup> Street, New York, NY 10023.

**II. ELIGIBILITY**

Entrants must be eighteen (18) years of age (or the applicable local age of majority) or older as of Wednesday, February 15, 2023, and a legal United States resident residing in the following counties in the states of North Carolina and Virginia: North Carolina – Chatham, Cumberland, Durham, Edgecombe, Franklin, Granville, Halifax, Harnett, Hoke, Johnston, Lee, Moore, Nash, Northampton, Orange, Person, Sampson, Vance, Wake, Warren, Wilson and Wayne counties; Virginia - Mecklenburg County.

#### **IV. HOW AND WHEN WINNERS WILL BE SELECTED AND NOTIFIED**

**One (1) potential winner** will be selected by a random drawing from among all eligible entries received on or about **Thursday, February 23, 2023**. Sponsor may or may not draw and/or announce the winner's name on air.

**Potential winner will be notified by telephone on or about Thursday, February 23, 2023.** If contact with the potential winner is not made within seventy-two (72) hours from the time of notification attempt by Sponsor, the potential winner may be disqualified and an alternate may be selected from the remaining valid entries received, time permitting. Failure to timely comply with any requirement of these terms and conditions will result in a potential winner being deemed ineligible for any prize.

In the event a potential winner is deemed ineligible, fails to comply with sweepstakes procedures, or is not available to claim prize during specified dates, then an alternate winner will be selected at random from among the remaining entries, time permitting.

Final determination of winner is always conditional on verification of eligibility and compliance with all rules and procedures.

#### **V. PRIZES**

One (1) Prize is available. The Prize consists of a three (3) day/two (2) night trip for the winner and one (1) guest to Los Angeles, CA to attend LIVE's After Oscar Show from the Dolby Theatre at the Ovation Hollywood on March 13, 2023. Prize includes:

- Roundtrip economy-class airfare for two (2) persons (i.e., winner and guest) to/from a major airport near winner's residence and Los Angeles, CA (exact flights, schedule and route to be determined by Sponsor, in its sole discretion).
- Two (2) nights standard hotel accommodations (single room/double occupancy);
- Local ground transportation in Los Angeles, CA as determined by Sponsor;
- Two (2) VIP seats at LIVE's After Oscar Show from the Dolby Theatre at the Ovation Hollywood on March 13, 2023 and admissions to a special Sweepstakes winners' reception; and
- A \$250 prepaid gift card.

**Travel must be completed on dates determined by Sponsor. Winner and guest must travel on the same itinerary.**
