

ABC11's Trip to the 53rd Annual Country Music Awards Sweepstakes

OFFICIAL RULES

NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT IMPROVE ONE'S CHANCES OF WINNING. VOID WHERE PROHIBITED.

I. SPONSOR and PRIZE PROVIDER

WTVD Television, LLC, 411 Liberty Street, Durham, NC 27701 ("**ABC11**" or "**Sponsor**"). ABC11's Trip to the 53rd Annual CMA Awards" Sweepstakes ("**Sweepstakes**") sponsored locally by ABC11 ("**Prize Provider**").

II. SWEEPSTAKES PERIOD

The Sweepstakes begins on or about Monday, September 30th, 2019 at 12:00am Eastern Time ("**ET**") and ends on Sunday, October 6th, 2019 at 11:59 p.m. ET (the "**Sweepstakes Period**").

III. ELIGIBILITY

Only legal U.S. residents who are eighteen (18) years of age or older at the time of entry are eligible to enter. Employees of Sponsor or Prize Provider, or any organizations responsible for sponsoring, fulfilling, administering the Sweepstakes or supplying the prizes, and each of their respective parent, subsidiary, related and affiliated companies, as well as persons involved in the production, and the immediate family and household members of all such foregoing individuals, are not eligible to enter or win. "Immediate family members" shall mean parents, stepparents, children, stepchildren, siblings, stepsiblings, or spouses, regardless of where they live. "Household members" shall mean people who share the same residence at least three (3) months a year, whether related or not. Potential winner may be required to provide proof of eligibility prior to prize award. Subject to all applicable federal, state, local, and municipal laws and regulations. Potential Winner and guest must be able to travel on dates specified by Sponsor.

IV. HOW AND WHEN TO ENTER

To enter the Sweepstakes, entrants must navigate the Internet to the www.abc11.com website, and located the Sweepstakes-themed graphic on the homepage. By clicking on the Sweepstakes graphic, entrants will be directed to the Sweepstakes entry page. Alternatively, entrants may navigate the Internet directly to <http://abc11.com/cma-awards/> to enter.

To enter the Sweepstakes, you must be a registered member of Disney/ABC/ESPN ("Member"), which is administered by One ID.

Existing Member: As a Member, you may enter the Sweepstakes by logging into your Member account, with your user name or email address and password, and following the entry instructions. If you login into your account using Facebook, you will be asked to allow Facebook's "Basic App Permissions," which is required in order to login to your account and participate in the Sweepstakes.

Non-Member: If you are not a Member, you may create a Member account, free of charge, by following the registration prompts and providing the requested information, such as Name, Mailing Address, Phone Number and Email Address on the registration form through the "sign up" or similar section on the registration/login screen. By creating a Member account, you acknowledge your agreement to the Terms of Use (available at <https://disneytermsofuse.com/>). Upon becoming a Member and meeting eligibility requirements, you may enter the Sweepstakes by following the instructions.

NOTE: During the registration and entry process, you may be asked to consent to receive promotional and marketing emails from ABC, ESPN and/or other members of the Walt Disney family of companies.

Consenting to receive promotional, marketing or reminder emails is optional, does not have to be agreed to in order to be eligible to enter the Sweepstakes and does not improve your chances of winning. In the event you do consent to receive these emails, the use of such emails shall be subject to ABC's Privacy Policy, available at <http://disneyprivacycenter.com/>. During the entry process, you may be asked to "like" Sponsor's Facebook page. Consenting to "like" Sponsor's Facebook page is optional and does not improve your chances of winning.

By clicking the check box next to the statement: "I have read and accept these Official Rules," and the submit button, you signify that you have read and agree to these official rules and meet the eligibility requirements. If you do not check the box indicating your confirmation of and agreement to the above, then you will not be entered in the Sweepstakes and cannot win a prize.

Limit one (1) entry per person every twenty-four (24) hours during the Sweepstakes Period, regardless of the number of email addresses or accounts a person may have. For the purposes of this Sweepstakes, a "weekday" is defined as beginning at 12:01 am ET and ending 11:59 pm ET the same day. Entries for any weekday can be submitted online from 12:01 am ET to 11:59 pm ET. **All entries must be received by 11:59 p.m. ET on Sunday, October 6th, 2019.** Proof of entering information on the entry form is not considered proof of delivery or receipt of such entry. Personal information collected in connection with this Sweepstakes will be treated in accordance with Sponsor's Privacy Policy, available at <http://disneyprivacycenter.com/>.

If a mobile device is used to enter the Sweepstakes, standard data charges may apply. Consult your carrier.

Sponsor can provide no technical support and accepts no responsibility for insuring the receipt or successful submission of your entry. Mass entries or entries generated by a script, macro, or use of automated methods will be disqualified. If for any reason the Sweepstakes is not capable of running as planned, including infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or other causes that corrupt or affect the administration, security, fairness, integrity or proper conduct of the Sweepstakes, Sponsor reserves the right, in its sole discretion, to disqualify any individual who tampers with the entry process, and to cancel, modify or suspend the Sweepstakes. If canceled, Sponsor reserves the right at its discretion to determine the winner using all non-suspect eligible entries received up to the time of cancellation. Sponsor is not responsible for failed, partial, delayed or garbled computer transmissions, or for technical failures of any kind in connection with entries or the entry process, including but not limited to electronic malfunction or damage of any network, hardware or software. In the event of a dispute over an electronic entry, prize will be awarded to the authorized subscriber of the email account, not the name on the entry form.

V. HOW AND WHEN WINNERS WILL BE SELECTED AND NOTIFIED

One (1) Grand Prize winner will be selected via a random drawing from among all eligible entries received during the Sweepstakes Period. Winner's name will be drawn after the entry deadline at 11:59pm ET on October 6th. **Odds of winning a prize depends on total number of eligible entries received during the Sweepstakes Period.** Limit one (1) prize per person for the duration of the Sweepstakes.

- ENTRY PERIOD START: On or about Monday, September 30th, 2019 12:00 am ET.
- ENTRY PERIOD DEADLINE: Sunday, October 6th, 2019 11:59 pm ET.
- DRAWING & NOTIFICATION: On or about Monday, October 7th, 2019 2:00 pm ET.

Winner will be contacted by the email listed on his/her Member account. Failure to respond to the initial verification email within forty-eight (48) hours after initial notification to the potential winner or return of the email notification as undeliverable after two (2) attempts will result in disqualification and award of

the prize to an alternate winner. Potential winner will be required to complete, sign and return within two (2) business days of transmission, an Affidavit of Eligibility, Release and Indemnification, and a Publicity Release where allowed by law, W-9 Form and any other documentation required by Sponsor (collectively, "**Verification Documents**"). If potential winner does not respond to the initial notification within forty-eight (48) hours as set forth above, if Verification Documents are not returned to Sponsor within the specified time period, if potential winner cannot use the Grand Prize (as defined below) on the designated dates, if any prize notification or prize is returned as non-deliverable, if potential winner is found to be ineligible or otherwise not in compliance with these Official Rules, or if potential winner cannot or does not accept the prize for any reason, prize may be forfeited and potential winner will be disqualified without compensation of any kind and an alternate winner may be selected in a random drawing (time permitting) from remaining eligible entries received.

In the event of any dispute concerning the identity of any entrant, the entry will be deemed submitted by the natural person who is the authorized holder of the email listed in the Member account. "Authorized account holder" is defined as the natural person who is assigned to an email address by an Internet access provider, online service provider, or other organization (e.g., business, educational institution, etc.) that is responsible for assigning email addresses for the domain associated with the submitted email address.

VI. GRAND PRIZE

One (1) winner shall receive a trip for two (2) persons (winner and guest) to The 53rd Annual CMA Awards Ceremony in Nashville, Tennessee, including the following (collectively, the "**Grand Prize**"):

- Roundtrip economy-class airfare for two (2) persons from a major airport nearest to winner's residence and Nashville, TN (exact airline and travel route to be determined by Sponsor, in its sole discretion);

 - Airport meet and greet by a Gaylord representative and roundtrip transportation to/from airport and hotel;
 - Daily resort access, including wired and wireless high speed internet access in guest rooms and atriums; fitness center; designated complimentary in-room beverages; daily newspaper, and more;
 - In-house concierge and designated escort to CMA Awards group events;
- Two (2) tickets to the Country Music Hall of Fame® and Museum; and
- A minimum of one (1) commemorative CMA Awards gift bag, with a collectible autographed by a country music artist (subject to availability).

The approximate retail value ("**ARV**") of the Grand Prize is **\$2,500**. The ARV of prizes are furnished by the prize suppliers. Actual final value of the Grand Prize may vary, and, under no circumstances will winner receive the difference between ARV and actual final value of Grand Prize in cash.

If winner elects to travel without a guest, no additional compensation will be awarded. Each winner and his or her companions must travel together on the same itinerary and possess all required travel documents, including a valid photo ID.

Sponsor is not responsible for cancellation or preemption of show/event or for other circumstances that make it impractical or impossible to fulfill this element of the prize. In the event winner and/or his or her guest engage in behavior that (as determined by Sponsor in Sponsor's sole discretion) is obnoxious or threatening, illegal or that is intended to annoy, abuse, threaten or harass any other person, Sponsor reserves the right to terminate the trip or other applicable experience early, in whole or in part, and send winner and travel companion home with no further compensation.

VI. RELEASES

Sponsor reserves the right, in its sole discretion, to disqualify any individual who tampers with the entry process and to cancel, terminate, modify and/or suspend the Sweepstakes in the event of tampering or other circumstances, including but not limited to acts of God or civil disturbance that render it impractical or impossible to complete or fulfill the sweepstakes as originally planned.
