

ABC11 Women's Empowerment 2023 Giveaway
OFFICIAL RULES

NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN. VOID WHERE PROHIBITED.

I. SPONSOR: WTVD Television, LLC, 411 Liberty Street, Durham, NC 27701 ("**Sponsor**").

II. SWEEPSTAKES PERIOD: ABC11's Women's Empowerment 2023 Giveaway (the "**Sweepstakes**") begins on **Friday, March 10, 2023 at 4:00pm Eastern Time ("ET")** and ends on **Friday, March 10, 2023 at 8:00pm ET** (the "**Sweepstakes Period**").

III. ELIGIBILITY: Only legal United States residents who are eighteen (18) years of age or older at the time of entry and reside in the WTVD-TV Designated Market Area as determined by Nielsen Media Research Services ("**DMA**") are eligible to enter. The DMA covers the following counties in the states of North Carolina and Virginia: North Carolina – Chatham, Cumberland, Durham, Edgecombe, Franklin, Granville, Halifax, Harnett, Hoke, Johnston, Lee, Moore, Nash, Northampton, Orange, Person, Sampson, Vance, Wake, Warren, Wilson and Wayne counties. Virginia - Mecklenburg County. V. WINNER SELECTION AND NOTIFICATION: One (1) potential winner will be selected via random drawing from among all eligible entries received during the Sweepstakes Period. Random drawing will be conducted by a representative of the Sponsor whose decisions are final. **Odds of winning a prize depend on total number of eligible entries received during the Sweepstakes Period.** Limit one (1) prize per person and one (1) prize per household for the duration of the Sweepstakes.

DRAWING & NOTIFICATION: Potential winner's name will be drawn on or about Tuesday, March 14, 2023 and potential winner will be notified by Sponsor shortly thereafter.

Potential winner will be notified by phone or email using information from their entry form. Failure to respond within forty-eight (48) hours after initial notification to the potential winner will result in disqualification and award of the Prize to an alternate winner.
