- I. SPONSOR: WTVD Television, LLC, 411 Liberty Street, Durham, NC 27701 ("Sponsor").
- II. SWEEPSTAKES PERIOD: ABC11's Secret Santa Word Giveaway 2025 (the "Sweepstakes") is brought to you in connection with the *ABC11 CrossRoads Ford Raleigh Christmas Parade presented by Shop Local Raleigh* (the "Parade"). The Sweepstakes will begin on or about 9:30am Eastern Time ("ET") on Saturday, November 22, 2025 and will end at 11:59pm ET on Saturday, November 22, 2025 (the "Sweepstakes Period").
- **III. ELIGIBILITY**: Only legal U.S. residents who are eighteen (18) years of age or older at the time of entry and reside in the WTVD-TV Designated Market Area as determined by Nielsen Media Research Services ("**DMA**") are eligible to enter. Entrants who properly submit the correct Secret Word (including the correct spelling) during the Sweepstakes Period and who are in compliance with all eligibility requirements listed above shall receive one (1) entry into the Sweepstakes.
